**GUARDIAN AD LITEM'S RECOMMENDATION AS TO HUSBAND'S
AMENDED MOTION FOR REINSTATEMENT OF BRANDON CROTTY, LMHC, CAP**

In response to the Father's Amended Motion For Reinstatement of Brandon Crotty as the
children's therapist, this is to advise the Court that I am strongly recommend against Mr. Crotty
again counseling [REDACTED].

Both children explained that they were not comfortable with Mr. Crotty as it was their belief that not only was he not listening to them but he was not taking what they shared with him seriously. These children, especially [REDACTED] are in need of someone whom they can confide in, trust, and to assist them in working their way through this difficult period. It is my belief that the children will not be able to confide in Mr. Crotty and therefore will not be able to obtain the necessary assistance, guidance and therapy that they need.

In direct response to the Father's motion, the Mother and Father both agreed on the children attending counseling and both were aware of and agreed on Mr. Crotty being the children's therapist. In fact, according to emails between the parents, the Mother re-scheduled an appointment with Mr. Crotty, at the Father's request, to accommodate the Father's schedule.

Thus, it would seem that the Mother neither [REDACTED] unilaterally chose Mr. Crotty nor unilaterally

scheduled appointments with him. Based on conversations with the children they do not believe that Mr. Crotty is “looking out” for their best interests. In fact, they believe that he is either not listening to or taking their concerns seriously. Thus, they are not likely to willingly open up and share their true feelings which is necessary for any form of counseling to truly be productive for these children. Thus, it is my belief that forcing the children to return to counseling with Mr. Crotty would very likely be detrimental to them and would be not in their best interests.

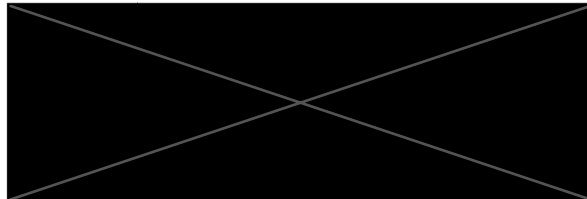
However, I do recommend that the children continue with their current counselor as from reports of the children they like her and feel comfortable with her, which should be one of, if not the primary consideration, (besides the person’s qualifications and experience) in choosing a therapist for the children.
